Proclamation

WHEREAS, the State of Mississippi will be impacted by extreme freezing temperatures and severe winter weather, including snow and freezing rain beginning February 13, 2021, and continuing, and thus state assistance may be necessary to support statewide local governments' response and recovery efforts; and

WHEREAS, the extreme freezing temperatures and severe winter weather may result in a shortage of residential heating fuel and may cause damage to public and private property throughout the State of Mississippi; and

WHEREAS, in consideration of the health and safety of the residents and the protection of their property within the affected areas, and in the public interest, all steps should be taken to protect people and property.

NOW, THEREFORE, I, Delbert Hosemann, Acting Governor of the State of Mississippi, pursuant to the authority vested in me under the Mississippi Constitution and Miss. Code Ann. § 33-15-11(b)(17), and in the public interest and for the general welfare, do hereby proclaim a State of Emergency to exist in the areas of the State of Mississippi affected by, or areas that may be affected by, the extreme freezing temperatures and severe winter weather beginning on February 13, 2021. The provisions of this Proclamation shall exist and remain in effect until such time as this threat to public safety shall cease to exist as prescribed in Section 33-15-11(b)(17), not to exceed a period of thirty (30) days.

FURTHER, all agencies of the State of Mississippi shall discharge their emergency responsibilities as deemed necessary as set forth in the State of Mississippi's Comprehensive Emergency Management Plan.

EXECUTIVE ORDER NO. 1545

WHEREAS, on February 14, 2021, pursuant to the Constitution of the State of Mississippi and Miss. Code Ann. § 33-15-1(b)(17), I issued a Proclamation declaring that a State of Emergency exists in the State of Mississippi as a result of extreme freezing temperatures and severe winter weather, including snow and freezing rain beginning February 13, 2021, and continuing; and

WHEREAS, the extreme freezing temperatures and severe winter weather beginning on February 13, 2021, has resulted in an increased utilization of residential heating fuel creating a shortage of residential heating fuel; and

WHEREAS, the extreme freezing temperatures and severe winter weather beginning on February 13, 2021, has limited and disrupted commercial vehicles from accomplishing their designated responsibilities of delivering residential heating fuel to customers throughout the State of Mississippi; and

WHEREAS, any unnecessary delay in the delivery of residential heating fuel to customers throughout the State of Mississippi during the State of Emergency will result in extreme hardship and threaten the public health and safety; and

WHEREAS, 49 C.F.R Section 390.23 authorizes a state governor, following the declaration of a State of Emergency, to exempt, for a period not to exceed thirty (30) days, any motor carrier or driver operating a commercial motor vehicle to provide direct assistance in providing emergency relief during an emergency from Parts 390 through 399 of Chapter 49, Code of Federal Regulations.

NOW, THEREFORE, I, Delbert Hosemann, Acting Governor of the State of Mississippi, pursuant to the authority vested in me under the Mississippi Constitution, the Mississippi Emergency Management Law as amended, Miss. Code Ann. § 33-15-1 *et seq.*, 49 C.F.R. Section 390.23, and in the public interest and for the general welfare, do hereby exempt any motor carrier or driver operating a commercial motor vehicle utilized for the delivery of residential heating fuel from Parts 390 through 399 of Chapter 49, Code of Federal Regulations. This Executive Order shall be effective upon execution and shall remain in full force and effect until 12:00 p.m. on Sunday, February 21, 2021, unless it is modified, amended, rescinded or superseded.
